091/22 Councillor Updates

IB sent the following update.

The Parish Council's application to have village gates on Lower Stoke by the Monkton Combe school fields has been rejected by Wiltshire Highways for traffic safety reasons.

Our application for village gates on Midford Lane entering the residential 20 mph stretch has been accepted in principle. Wiltshire Highways are progressing this. Further details will be provided when available.

The Parish Council has applied for two further pedestrian and resident safety improvements:

- Reduction of the speed limit from 30mph to 20 mph on Church Lane
- Installation of permanent traffic management (e.g., creation of a chicane type island) on Middle Stoke (A36 end).

These two recent applications have the support of our County Councillor Johnny Kidney.

The Wiltshire Highways engineer has visited the locations and supports the applications in principle. MM will liaise with Sheena Broadhead to inform residents of the proposals, via the website and newsletter.

We will publish further details when available.

JS reported that the the temporary barriers on Woods Hill are constantly being moved by motorists. LSPC are awaiting the permanent barriers by Wiltshire CC

FF reported that the 4 other LSPC noticeboards should have the protective covers fitted soon.

MM- nothing major of note regarding the website this month. 226 subscribers to date.

LP reported that The Hop Pole committee are still waiting for a decision regarding match funding.

The £300,000 COF grant issued by the DLUHC in 2021 was the bedrock behind LSCBS's strategy of reopening the Hop Pole. The deadline for the COF announcement was 19th October 2022 but the political crisis in Westminster has resulted in this decision being delayed. The DLUHC "are working to provide applicants with an outcome as soon as possible". The management committee were asked to continue with the project and will work hard to explore additional grant opportunities and revenue stream.

LP will arrange for John Adler to speak to the LSPC in December about the Freshford and Limpley Stoke Community Energy Project. The project is aiming to generate power for the 2 villages and BWCE will be involved in the grant processes.
